Planning & Land Use Presentation

Christopher Murray representing Sacred Heart High School: The project is about a small structure. Announced that the President of Sacred Heart High School is also on hand. Sacred Heart was opened in 1907 and is located on Griffin Avenue. The school itself is in the historic preservation. This is a unique opportunity for this school to have a gymnasium. Currently they come to Lincoln Park to practice. They are asking for entitlements and approval of plans. Zoning administrator adjustment is also required as well as a parking approval.

Speakers:

<u>Carmen Diaz</u>: alumna and resident/owner of property in LH. She is here to support the building of a gymnasium for the high school.

<u>Robert Vega:</u> is here in support of the building. He feels there is some opposition to the building. He feels the gym is all about the safety of the girls. He grew up in Lincoln Heights and knows many of the people that hang out at the park and knows the danger for the girls at Lincoln Park. This is about safety for the girls.

<u>Gloria Sosa:</u> is a graduate of Sacred Heart. This project is important to the girls and the community of Lincoln heights. This is the only all-girls catholic high school in this area. Its critical for the girls to have a safe place.

<u>Margarita Amador:</u> she is a stakeholder in LH. Wants everyone to think about the safety of the girls. This will become a building for the community. The project will bring a lot of attention in LH.

Alice Collier: is the president of the alumni association. Feels that the gym is a great thing for the school and wants support.

Public Speakers:

<u>Ray Rodriguez</u>: works for Soledad enrichment action, does gang intervention for LH. On October 24th they are having an event and March to voice out that we need peace in the community. We have had a high crime rate in the last 3 months. There will be another peace march on November 7th in Lincoln Heights. Wants to create a movement to create a voice.

Presentation Gaston Mantero: MGM Branch, specializes in empowering youth to be part of their heritage. He specializes in arts. He would like to get sponsors because the City of Los Angeles does not have any funds for the cultural arts. Folklorama is from October 17 to October 25. This is a big international festival for the City of Los Angeles. This year there are 3 major groups helping, Ukranian and Ehtiopan communities. United Nations groups are also involved. Gaston says that supporting the event will not cost the neighborhood council anything.
