## I. Welcome/Call to order/Roll Call/Review minutes

Meeting called to order by Sevin Riley, Chair, at 6:35pm. ## II. Speaker from LA Planning Dept on ReCode LA

Nick Maricich Senior City Planner working on Recode LA gave a presentation on the plan to update LA's codes which were written in 1946. It is a 5-year effort which started in 2013 and will be finished in 2018. It is not about rezoning, but about reorganizing - about process, not policy; the decisions about what kind of development will occur remains with the communities and their community plans. He described the patchwork system that exists today which requires a developer to go to many different departments to find out what is required. The new system identifies the form, frontage and use in the case number and all the rules will be in one section.

Ill. Report on visit to Planning Department on 4-18-16 re development at 2626 Lacy Street Richard Larsen and Sevin went to the Planning Department and met with Michael Sin, the planner in charge of the Lacy Street project. We were able to obtain the drawings of the project, which will have 235,000 sq feet of mixed use construction with commercial on the first floor, parking underground and 16,000 sq ft residential. Drawings were shown to the committee. The project is in the initial phase.

### IV. Report on visit with Jose Rodriguez on 4-25-16

Sevin and Richard Larsen talked to Jose about the zoning violations at Lacy Lofts. He said he would look into it and asked for a list of bullet-points. Nick Maricich said that the new owner should abide by the original zoning. We asked Jose about the dangerous intersection at Prince and Broadway but did not have time to address that subject at the meeting. Both subjects will be agendized for June.
