Campaign Contributions and Behested Payments

Summary: The Lincoln Heights Neighborhood Council supports Council File 19-0046 and efforts to limit the influence of non-individuals and developers on our democracy. We urge the council to support all of the recommendations unanimously approved by the Ethics Commission on February 19th, which include:

- Ban contributions and fundraising by non-individuals and developers
- Ban fundraising and bundling by non-individuals, developers, bidders, lobbyists, and contractors
- Ban behested payments from restricted sources and enhance disclosure

A review by Ethics Staff found 33 enforcement orders involving developers and development projects. This amounted to over \$1 million in administrative penalties, over half of the penalties for that period. The recent news coverage raises further ethical concerns about pay-to-play politics occurring in City Hall. By banning contributions from those with projects requiring discretionary approval we remove a clear conflict of interest. The proposal offers a closely drawn solution that also covers applicants and principals. It additionally closes fundraising and bundling loopholes for developers, contractors, and lobbyists.

Banning contributions from non-individuals increases transparency to voters, and offers administrative, auditing, and enforcement clarity for donors, candidates, campaign staff, and Ethics Staff.

To ensure that these recommendations effectively restrict developers' ability to influence elected officials, we would also encourage Council to consider restricting electeds' ability to solicit behested payments from developers. This measure would prevent developers from circumventing the contribution ban by gaining influence through behested payments. We encourage City Council to take swift action and adopt the Ethics Commission's recommendations to restore public faith in our local government.

Summary: Lincoln Heights Neighborhood Council supports Council Files 15-1088-S1 and 12-1269-S5 to improve our Matching Funds Program's ability to achieve the goals of the program, including to:

- improve the ability of grassroots candidates to run viable campaigns for office;
- incentivize candidates to communicate with a broader set of constituents;
- elect representatives who are responsive to the needs of all their residents; and to
- help restore trust in our government and local institutions.

We urge you to support the Ethics Commission February 19th recommendations to strengthen the program by lowering the aggregate qualifying threshold and requiring matching funds candidates to participate in a debate, or a town hall if other candidates do not agree to a debate. The Commission unanimously approved the thresholds proposed by Councilmember Bonin in his October 5th Motion.

The program's current threshold of \$20,000 for City Council candidates could be unattainable,

even for candidates that have significant levels of support in their home district. A lower aggregate qualifying threshold will allow candidates who demonstrate their viability to boost their campaigns with matching funds. A qualifying threshold equal to 100 times the maximum eligible contribution amount is a fair threshold for candidates to meet.

We also agree that in order to receive matching funds, candidates should engage in a debate with his/her opponents. These debates will allow voters to better understand each candidate's positions and make a more informed decision about their vote. In the case where candidates do not agree to a debate, a town hall event that allows voters to ask questions of a candidate is a suitable substitute that will achieve a similar result.

We urge Council to adopt the Ethics Commission's recommendations to strengthen our democracy with these improvements to the matching funds program.
