

The Lincoln Heights Tutorial Program (LHTP) provides year-round services for students in grades K-12th with tutoring, homework assistance, work experience training, Junior Youth Club (JYC) & Youth United for Community Action (YUCA) youth clubs, youth leadership development, civic engagement, college tours, and college preparation. Our after-school tutorial programs serve children and youth in homework help, math, reading, writing, and computer literacy. Our youth clubs serve to build leadership skills amongst the local high school youth, and to give them opportunities to serve their own community. Our 3rd leadership development team of youth that we have, is titled the "Increase the Peace" ("IP") Advocacy committee, with the motto of "Bringing Unity to Our Community". This team has an emphasis on advocacy for our community. This work centers around increasing the opportunities for community youth agencies and youth to come together for specific events, designed to break down tensions amongst youth from the various parts of our neighborhood, and to reduce racial tensions between the Asian and Latino youth. Two of the events the committee hosts are the "Increase the Peace" Green Space Challenge. The LHNC Grant funds will be used towards material and supplies, food, leadership development & training for our after-school tutoring services, JYC & YUCA youth clubs, and LHTP "Increase the Peace" youth advocacy meetings and events. 5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large.

LHTP's after school programs and services are provided in the Hybrid format and benefit our K-12th children, youth, and teens in Lincoln Heights. Our tutoring services help to keep our children focused on their studies and to excel in their academics. Our JYC & YUCA youth clubs provide community service, social, advocacy, inter-agency events, college tours, leadership training, mentorship, work experience, and college Prep for youth members in grades 6th-12th. In addition, to Our "Increase the Peace" Neighborhood Clean-up is a direct benefit to all of the residents and businesses in the surrounding blocks where our "IP" youth cleaning teams are assigned to clean. Our "Increase the Peace" Green Space Challenge event takes place at Lincoln Park and teaches about the importance of environmental preservation, planting flowers, utilizing parks and green space, outdoor activity and exercise to improve their physical and mental health. All invited agencies and guests will join together to promote the vision of "Increase the Peace" of Bringing Unity to our Community. There are opportunities for collaboration with the LHNC Board members for outreach and participation with our "Increase the Peace" events.

Our tutoring staff were able to help their students to stay focused on their schoolwork and homework assignments, improve their study habits, increase grades, quiz, and tests scores, and showed good attendance and behavior. LHTP High School Tutoring Staff had steady after school jobs, stipends, and Workforce training. Our JYC & YUCA youth club members participated in a variety of community service, social, advocacy, virtual college tours, workshops, and hosted Food Pantry Days to distribute groceries and school supplies to our Lincoln Heights families.

Our K-9th grade students were provided hundreds of hours of free hybrid after school tutoring and homework assistance on a regular basis.


